**PARKING INFORMATION**

Please read the following information carefully if you plan to bring a car to school next year.

**Our 24-hour parking spaces are very limited and decals for these spaces are sold on a first-come, first-serve basis, starting with building residents.** Once these lots are full, your name will be put on a waiting list and you will be notified if a space becomes available. If you commute to classes, you may purchase a commuter parking decal. Commuter lots are **not** available for overnight parking. **If you purchase a commuter decal, you are entitled to park in any of the commuter lots, but you are not guaranteed a spot in any one lot.**

**PLEASE NOTE:**

- ~ INCOMPLETE APPLICATIONS WILL **NOT** BE PROCESSED.
- ~ PAYMENTS **MUST** BE ENCLOSED (check or money order only ~ we cannot process payment by credit card).
- ~ MAIL PAYMENT AND COMPLETED APPLICATION DIRECTLY TO CLARK UNIVERSITY POLICE, NOT TO STUDENT RECORDS.
- ~ ANY OUTSTANDING PARKING CITATIONS MUST BE PAID BEFORE A DECAL WILL BE ISSUED TO YOU.

- *For those of you, who plan to park on Worcester streets rather than in a University lot, please be advised that the City of Worcester strictly enforces its winter parking restrictions. To familiarize yourself with these regulations you are encouraged to obtain a copy of our parking Rules and Regulations, available in the University Police office.*

PARKING INFORMATION

ALL STUDENTS PLEASE NOTE:

**If your car is not registered in Massachusetts,**

Massachusetts law requires that you fill out a “Nonresident Student Vehicle Information Form” and file it with the University Police. In return, you will receive a decal, free of charge, which **must** be displayed on your car. Failure to comply carries up to a \$50.00 fine.

**This law applies to all students, regardless of whether or not you purchase a Clark University parking decal.**

**A new form must be submitted each year.**

Please fill out (in black ink or typed) the Out of State Motor Vehicle form and return it to the University Police department.
